I. POPUN

Wenechareno fiti met sipwe fori me pwan namoteoch kena, ewe Pioinin APWAKSEFAN seni ewe Pacific ("APWAKSEFAN") a kan achocho ngeni kaworen aninisin moni ngeni chon safei kena ra kan mochen angangen aninisin tumunun safei kena ra kan auchean safean apwaksefan me pwan rese kan tongeni ar repwe moni anongonong won an emon me emon sakusokun pekin moni. Ewe popun ren ei annuk a kan ren ar repwe forata ew esapw koput ngeni, foforieoch ngeni me pwan weweno chok foforun ren kaworen aninisin pekin moni ngeni ekkena sakkun chon safei.

Ei annuk ese kan aeoeo ngeni:

- Angangen aninis kena ina rese kan ekkiekir pwe ra kan auchea ren pekin safei, usun a aporaus usun non Section III.B. me pwan
- Angangen aninis kena ir ra kan kaworeno seni chon awora kena resapw ir chon APWAKSEFAN ina meni ir repwene safeani ika awora angangen aninis kena ngeni chon safei kena non nenien APWAKSEFAN kena. Exhibit A seni ei annuk a kan maaketiw chon awora kena ir resapw chon APWAKSEFAN ina ir ra kan awora angangen aninis kena non nenien APWAKSEFAN kena.

Porausen kapasen ewe annuk an kan fofor ngeni asiwininon non ew fansoun ese nifinifin non mefien APWAKSEFAN.

II. WEWEN KENA

Ren ewe popun seni ei annuk, ekkewe porausen kapasen me fan ra kan aweweno usun ra tapweto:

Awukukun Ra kan Unusenapen Momo ngenir: Ewe wukukun momo ra kan iteiten unusenapen ioni seni chon safei kena ina ir a wor ar insurens a pwonu ekkena safei ra aucheano ren tumunur. Wukukun kena ra kan iteiten unusenapen momo ngenir ra kan apachereno anongonong won ewe sakkun fofor ra ekkieki me pwan finata anongonong won ewe achufengenin wukukun ina repwene kan angei seni Medicare me pwan ewe chon angei Medicare fengen ren ewe aninis.

Family: Ew mwich seni ruwow ika chomongen aramas kena ir ra nonom fengen me pwan ina ir ra kan aramas fengen seni uputiw, pupunu, ika mowuti. Ika pwe ewe chon safei a kleimini emon aramas pwe emon noun won ar U.S. income tax return, iwe ir meni repwene ekkiekieno emon nour ren popun kena seni ei annuk.

An Family Monitonong:

- Mei pachenong monitonong (me mwan anongonongen takises)ra aweweni pwe niwinir kena, aninisin momon ese wor angang, aninisin momon chon angang, Social Security, monitonongen Supplemental Security, aninisin aramas meinisin, momon sonfiu kena seni nom, aninisin chon menauweno kena, pension ika monitonongen retirement, interest, dividends, rent kena, royalties, monitonong seni pisekir kena, trusts kena, aninisin sukun, alimony, aninisin semirit, aninis seni nukun ewe imw, me pwan ekkoch sakopaten nenien angeiin aninis kena;
- Mei pachenong monitonong ren meinisin aramas kena ra pachenong non ewe awewen ren "Family". Monitonong ren ekkena ir resapw aramaser, usun chok chon nomom rer kena, ra kan eiemuwow;
- Eiemuwow aninis kena resapw ren pekin moni kena (usun chok food stamps me pwan aninisin mon imweimw kena); me pwan
- Eiemuwow capital gains kena ika nusuno kena.

Pisekin Family kena Ra Tongeni Asiwinireno ngeni moni:

- Mei pachenong nenien angaiin aninis kena ina ra kan non moni ika momono non moni nupwen ra mochen me pwan
- Mei pachenong pisekir kena ra kan tongeni asiwinano ngeni moni ren meinisin aramas kena ra pachenong non ewe awewen ren "Family". Pisekir kena ra kan tongeni asiwinano ngeni moni ren aramas kena esapw ir aramaser, usun chok chon nom rer kena, ra kan eiemuwow.

Osupwangen An Chon Safei Repwe Tongeni Moni Safeier: Rese tongeni ar repwe moni eoch pekin ika meinisin momon ar safei kena ina ewe unusenapen mon safei kena ra kan napeno seni 15% seni an ewe family monitonong.

Safean Mei Tufich Ngeni: Usun a aweweno seni Medicare, “angangen aninisin tumunun safei ika pisekin aninis kena ra mochen ren ar repwe cheki semwenir ika safeani ew semwen, feiengaw, sakkun semwen, semwen, ika pusin asisinin semwen kena me pwan ina ra kan tori awukukun kena ra kan etiwa ren safei” (<https://www.medicare.gov/glossary/m.html>, August, 2016).

Ese wor nour insurens: Chon safei kena ese wor nour insurens ika aninisin pwan ew mwich ren ar repwe tori an ewe mwan/fefin oforun momoni kena ngeni chon awora tumunun safei kena.

Ese Naf Nour Insurens: Chon safei kena fiti ekkoch awukukun ren insurens ika aninisin pwan ew mwich ren ar repwe tori momo kena repwe moni ngeni chon awora tumunun safei kena nge ina meni epwene wor ar momo kena seni pusin ewe chon safei ina a kan napeno seni an ewe mwan/fehin we tongeni ren pekin moni an epwene moni.

III. ANNUK

A. Amwenin kena

Aninisin pekin moni a kan chok kaworeno ren angangen aninis kena ra tufich ren safeien chon safei kena ra tori mochenin nafeno kena me fan ei annuk. Aninisin pekin moni a kan kaworeno seni non ese wor momon ika anongonong won koturutuwen mon tumun won an family monitonong.

Aninisin pekin moni esapw kan ekkieki pwe epwe ew asiwinin ren pusin eom fori met kopwe fofori. Chon safei kena ra kan ekkieki pwe repwe tipeew ngeni an APWAKSEFAN kewe atetenin fofor kena ren ar repwe angei aninisin pekin moni me pwan ren ar repwe akatonong ngeni ewe mon ren ar tumun anongonong won an emon me emon tongeni an epwe moni. Chon safei kena repwene aninisin non kuuten pwan ekkoch sakkun kena ren momo me mwan ar repwene apunguno ren aninisin pekin moni me fan ei annuk.

Ekkena emon me emon rese kan wor nour insurens fiti ewe atotongeni ren pekin moni ar repwe kamo insurens ren safei repwene pesei ngenir ar repwene fori ena ren ar repwe tumunu ar atotongeni angangen aninisin tumunun safei kena ren an ewe chon safei we unusenapen pechakunen me pwan pechakunenon pusin inisir.

APWAKINO ese kan awora tumunun safeien atepwanepwan me pwan ese kan angei ew rumwen atepwanepwan ika ese kan angei tongenin sakonon sineieochunon kena ina epwene fori an epwene fichino ar repwe eitiwa emon me emon kena ir ra mochen eochunon tumunur ren ew atepwanepwanen sakkun safeien semwen. Emon me emon aramas kena ra mochen tumunun safeien atepwanepwan repwene amweteno ngeni pwan ew neni non ew sakkun ina a kan fofor ngeni 42 CFR 482.12(f)(2).

B. Angangen Aninis kena ra kan Nafeno

Ekkei angangen aninisin tumunun safei ra tapweto ra kan nafeno ren aninisin pekin moni me fan ei annuk.

- Angangen aninisin apwaksefan kena ra kaworeno seni APWAKSEFAN ren ew sakkun semwen ina a kan, ika pwe rese kan mutir safeani, epwene kan feno ngeni ew ngawenon siwin non ususun pechakunen ren emon aramas; Angangen aninis kena ra kan anongonong won an ewe dokter we me pwan/ika therapist we akoten tumunun safean ina a kan anongonong won safei mei namot ngeni me pwan pechakun epwe angei me pwan

- Angangen aninis kena ra nafeno mei pachenong ekkena ra fororino seni chon awora kena ir ra kan angang seni APWAKSEFAN usun a maaketiw non Exhibit A.

Ekkei angangen anisisin tumun ra tapweto rese kan nafeno ren anisisin pekin moni me fan ei annuk.

- Angangen aninis kena ina ir rese kan safei mei namot, mei pachenong angangen anisisin pechakunen inis kena me pwan
- Angangen aninis kena ir ra kan kaworeno seni chon awora kena resapw ir chon APWAKSEFAN ina meni ir repwene safeani ika awora angangen aninis kena ngeni chon safei kena non nenien APWAKSEFAN kena. Exhibit A seni ei annuk a kan maaketiw chon awora kena ir resapw chon APWAKSEFAN ina ir ra kan awora angangen aninis kena non nenien APWAKSEFAN kena. Angangen aninis kena ra kan fororino seni chon awora kena ir resapw APWAKSEFAN repwene eiemuno momonon ngeni chon safei kena.

C. Nafenon Chon Safei

Finitan nafenon chon safei esapw kan uwanong non fororun ierin, met ii emon, sakkun aramas, sakkun finien nisouu ika namenam a kan emon chon non.

Meinisin ekkei wunungat tetenin ra tapweto repwene kan torir ren ar repwe nafeno ren anisisin pekin moni me fan ei annu:

1. Tesin Pisekir ra kan Tongeni Asiwinano Ngeni Moni: Pisekin family kena ra tongeni asiwinano ngeni moni ra kan wewe ngeni ika kukun seni \$50,000;
2. Tesin Monitonong: Chon safei kena fiti an family monitonong ren 300% ika kukun seni an ewe Federal Amwenin Wowngaw ren Hawaii non apechakun non ewe fansoun ren ewe finatan (FPG) a tori ewe tetenin Tesin Monitonong. Akoturutiwen momo kena ra finita won ew awukukunon awukuk usun a tapweto:

Chon safei kena fiti monitonongen family ina a kan napeno seni 300% seni ewe FPG ra kan nafeno ngeni ar repwe angei akoturutiwen awukukun kena ren ar rese tongeni

moni safeier ikewe unusen mon safei kena ra kan napeno seni 15% seni an ewe family monitonong. Ewe awukukun a akoturutiw esapw kan wattenno seni ekkewe wukukun ra kan iteiten unusen momo ngonuk.

3. Tesin Nenien Nonom Chon safei epwene kan emon U.S. citizen ika emon chon etto ikei me fan annuk ina ii a kan nonomfocheno non Hawaii.

Ekkiekin Nafenon Aninisin Pekin Moni: Non ewe attun ese kan wor nafenon aninis ren ar repwe finata an emon chon safei nafeno ren aninisin pekin moni seni ar eaea ekkewe wunungat tetenin me asan, iwe APWAKSEFAN epwene eaea pwan ekkoch nenien angeiin aninis kena ren an epwe finata nafeno me pwan wukukun akoturitiwen kena me pwan ei annuk. Ekkiekin nafeno epwene kan finata won ewe anongonongen ren an ewe chon safei wenewenen ususun kena ina epwene pachenong:

- Ese wor imwer ika angei tumun seni ew nenien tumunun ekkena ese wor imwer;
- Nafeno non programen aninisin pekin moni non state, federal ika nenien nonom kena, usun chok programen Fefin, Menukon me pwan Semirit kena (WIC), food stamps, programen aninisin mon mongon nanowas non sukun kena, kukunun monitonong/aninisin mon imweimw; me pwan
- Chon safei a kan mano fiti ese wor pisekir ra sinei usun.

D. Foforun Aeoeo me pwan Cheki

Ewe chon safei/noun chon safei we chon moni epwene kan awasano ewe Aeoeo ren Aninisin Pekin Moni, (Exhibit B) me pwan uwanong pusin an, taropwen pekin moni me pwan ekkoch poraus me pwan taropwen usun ra kan tungoreno seni APWAKSEFAN.

Chon safei ra kan aitata pwe emon fichin chon nafeno ren Medicaid/Quest repwene eisini pwe epwe aeoeo me pwan unusen tipeew ngeni an epwe awora ekkewe poraus ra mochen ren ar repwe awasano ewe aeoeon Medicaid/Quest.

APWAKSEFAN epwene cheki me pwan uwanong Aeoeo ren Aninisin Pekin Moni me pwan taropwen aninisin me pwan finata nafenon anongonong won ewe tetenin a kapas usun non Section III.C. Nafenon Chon Safei.

Repwene asinei ngeni ewe chon safei non maak usun an ewe mwan/feffin finitan nafeno. Ewe porausen kapasen ren nafenon aninisin pekin moni epwene kan ren ew fansoun onu maram seni ewe finata. Murin onu maram kena, iwe ewe chon safei epwene aeoeo sefan ren aninisin pekin moni me fan ei annuk. Ewe mochenin ren aninisin pekin moni epwene awukuksefan non ekkena fansoun ese nifinifin apachenongen poraus ra namot ngeni ewe finatan nafeno repwene kan sineieno.

Akoturutiwen mon kena usun a kapas usun me asan epwene aeoeo ngeni an ewe chon

safei we wukukun mon kena rese momono seni ewe raninin finata me pwan wukukun mon kena non mwach kaan ren ewe fansoun onu maram me murin ewe ranin finata. An chon safei nafeno ren aninisin pekin moni esapw kan fofori an epwene moni napeno seni ekkewe wukukun ra kan iteteiten unusen monawow ngeni chon safei kena fiti an insurens pwonu ekkena sakkun tumun mei namot ren safeien.

Ra kan fini nge ese ew repwe fofori pwe ew tungor ren aninisin pekin moni me pwan ew finata ren mochenin pekin moni a kan fisino me mwan angangen aninisin safeien mei namot ngeni ra kan ngeni. Nge ew chok, ewe finitan epwene fisino non ew fansoun non ewe attun ionin mon.

Poraus usun ei annuk me pwan aninis fiti awasinon ewe Aeoeon ren Aninisin Pekin Moni ra tongeni angei seni ewe department ren an Chon Safei Angangen Aninisin Pekin Moni kena a nonom non 226 North Kuakini Street, Honolulu, Hawaii 96817 ika seni fon non (808)544-3340.

E. Kakapas fengen ren ewe Annukun Aninisin Pekin Moni ngeni Chon Safei kena me pwan ewe Nenien Nonom

APWAKSEFAN epwene fori eochunon achochon kena an epwe kakapas usun ewe kaworenon ren ei annuk me pwan aninisin pekin moni me mwan foforon ekkena Extraordinary Collection Activities (ECA). Arongorongen ren ewe akaworen ren aninisin pekin moni epwene kan kaworeno seni sakopaten foforon kena ina mei pachenong, nge rese kan awukukuno chok ngeni:

- Apachetan ren apwaranon kena repwene tongeni kuuna ren arongorong kena non nenien katonong me pwan registerinong kena, An Chon Safei Angangen Aninisin Pekin Moni me pwan ekkoch nenien aramas meinisin kena non ewe nenien piopin usun a finita seni APWAKSEFAN;
- An chon safei momon safei kena epwene pachenong iteiten awukukun fosun fonu a kan asinei ngeni chon safei kena ren ewe kaworenon ren aninisin pekin moni me pwan ifa usun ar repwe angei apachenongen porausen;
- Poraus mei pachenong ewe annuk, Aeoeon ren Aninisin Pekin Moni me pwan Aporausen Aninisin Pekin Moni (Aporausen non Mecheresin Fosun Fonu) (Exhibit C) epwene pwan aronga ngeni meinisin won an APWAKSEFAN we internet website me pwan fori pwe epwe kaworeno nupwen ra tungor me pwan esapw pwan wor momon, mei pachenong seni taropwen posto; me pwan
- Ekkena arongorong me pwan aporausen poraus repwene kan katowow non pwan ekkoch neni kena me non ewe nenien nonom ra angang ngenir seni APWAKSEFAN seni non an APWAKSEFAN we foforon atorngeni nenien nonom kena.

Eochunon achocho kena repwene forino ren ar repwe finata ika emon chon safei a kan

nafeno ren aninisin pekin moni me fan ei annuk me mwan ar repwe foforinong non ECA usun a tapweto:

- Facho taropwen momon iteiten maram kena repwene kaworeno ngeni ewe chon safei/chon moni. Echo me echo taropwen momon safei kena epwene pachenong iteiten awukukun fosun fonu a kan asinei ngeni ewe chon safei/chon moni kena ren ewe kaworenon ren aninisin pekin moni me pwan ifa usun ar repwe angei apachenongen porausen, me pwan aeoeo ngeni. Ewe aruwanun taropwen momon iteiten maram (nasenon maaken arongorongen) epwene aporaus a ewe kaworenon ren aninisin pekin moni, aitata ewe ECA ina APWAKSEFAN a ekkieki pwe epwene apopotani ren an epwe angei momon me pwan pachenong ew nasenon ranin ina murin ECA epwene foforano (ina epwene esapw kis seni 30 ran murin ewe ranin seni ewe nasenon maaken arongorong). Ewe Aporausen Aninisin Pekin Moni (Amecheresin Aporausen non Fosun Fonu) epwene kaworeno fiti ewe taropwen fachon momon iteiten maram.

- Esapw kukun seni 30 ran me mwan ar apoputan ngeni ECA, satuni ar repwe asinei ngeni ewe chon safei non kapas usun ewe kaworenon ren aninisin pekin moni me pwan ifa usun an epwe angei apachenongen poraus me pwan aeoeo; me pwan
- Eochunon achocho kena repwene chekeno seni ewe Controller. ECA esapw kan poputa ika pwe ese dwor apungunon me mwan seni ewe Controller me pwan finata pwe eochunon achocho kena ra kan foforino.

Murin an ewe Controller a finata eochunon achocho kena ren ar repwe finata nafenon aninisin pekin moni ra kan forino, APWAKSEFAN epwene apoputani ECA mei pachenong repotin ese wor momon ngeni chon ioni me/ika ofesin repotin credit kena me pwan filin lawsuits kena. ECA esapw kan poputa me mwan 120 ran murin ewe aewin taropwen momon iteiten maram (taropwen momon murin towow) a kan kaworeno.

Murin poputan ECA, ika pwe ra kan asinei ngeni APWAKSEFAN ren ewe mochenin ar repwe aeoeo rein aninisin pekin moni me fan ei annuk seni ewe chon safei/mon moni, APWAKSEFAN epwene awora ewe Aporausen Aninisin Pekin Moni (Amechersin Aporausen non Fosun Fonu), Aeoeon ren Aninisin Pekin Moni me pwan maaken asinei ngeni ren ewe ranin sopwenon ren uwanongen ren ewe awasinon Aeoeon ren Aninisin Pekin Moni. Ewe ranin sopwenon epwene ewe manganon ranin ren 30 ran kena seni ewe ranin ren ewe maaken asinei ngeni ika 240 ran murin ewe aewin taropwen momon iteiten maram (taropwen momon murin katowow seni pioin). Nupwen ar angei ewe awunusenon wasinon Aeoeon ren Aninisin Pekin Moni murin ECA a poputa, ena sakkun ECA epwen saspeneno nupwen ewe foforun chekin. Ika echo unusenon awasinon Aeoeon ren Aninisin Pekin Moni ese kan angei me mwan ewe ranin sopwenon ra tichikino non ewe maaken asinei ngeni, iwe APWAKSEFAN epwene sopwesopweino ECA.

Ika pwe aninisin pekin moni a kan apunguno me pwan ra kan kuuna me murin pwe emon chon safei a kan angei monien mon ren feingawen kena/semwenin kena ina ra kan safeieno seni APWAKSEFAN, iwe ewe chon safei epwene fofori an epwene monsefani ngeni APWAKSEFAN. Ren awewe, ika pwe emon chon safei a angei aninisin pekin moni me pwan murin a kan angei ew apungunon ren feingawen kena a fis ngeni non ew accident non chitosa me pwan APWAKSEFAN a kan safeiani ewe chon safei ren ekkena feingaw, iwe ewe chon safei epwene wisen an epwe mon an ewe mwan/fein mon APWAKSEFAN, me pwan ekkena awukukun aninisin pekin moni repwene akunusefanireno.

Angangen aninis kena ra kan kaworeno seni chon awora kena resapw chon APWAKSEFAN kena non nenien APWAKSEFAN kena rese kan nafeno me fan ach FAP me pwan repwene eiemuno momor ngeni ewe chon safei.

Ren nafeno en kopwene kan emon United States citizen ika emon chon etto ikei me fan annuk ina ii a kan nonomfocheno non Hawaii. Pisekin eom family kewe me pwan monitonong repwene chekireno ren ar repwe kuuna ika pwe ir ra kan tori amwenin annuk kena ren awinin aninisin pekin moni.
